‘Powiew Młodego Jazzu’ (‘The Breath of Young Jazz’)
Jelenia Góra 19-21.10.2018

I GENERAL PROVISIONS

1. The Organizer of the Competition is Cultural Center Jelenia Góra
2. The aim of the Competition is promotion of jazz, new music projects and young musicians.
3. The Competition takes place on 20-21.10.2018, as part of XVII International ‘Krokus Jazz Festival.’
4. The Competition concerts are open to the public.
5. Participants are chosen by the Jury of the Competition appointed by the Organizer, based on tracks submitted to the Competition.

II TERMS AND CONDITIONS OF PARTICIPATION

1. The Competition is for novice musicians.
2. The Participants must be born in 1988 or later.
3. The winner of the main prize of former editions cannot compete.
4. As part of competitive presentation, the Participants perform three tracks. Total time of competitive presentation: 30 minutes.
5. Application for the Competition takes place through sending an application form (Card Applications) completed and signed and CD/DVD record of tracks submitted to the Competition and a photography of a band in the electronic version made in the level of

quality at least 300 dpi / JPG files or TIFF. Please do not send “plywood” with several pictures.

The deadline: 8.09. 2018. The date of receiving is deemed.

7. The Organizer of the Competition reserves the right to extend the term of sending an Application.
8. The submitted work is not returned.
9. The participants are obliged to participate within the time ordered by the Organizer.
10. The Organizer specifies the date, time and the order of the competition interview.
11. Candidates are notified of their classifying to the Competition and the date and time of their audition via e-mail no later than **10.09.2018**.
12. Applicants are required to confirm acceptance of the invitation to the competition by sending relevant information to the 18 September 2018.
13. If no reply is received within the deadline or in case of resignation, the Organizer reserves the right to choose the candidates from the reserve list.
14. The Organizer provides Participants of the Competition with free hotel accommodation (20 -21 10.2018) and halfboard. The Organizer offers also free entry to all festival events.
15. The cost of travel to Jelenia Góra is paid by the Participants.
16. The Participants of the Competition are required to participate in jam session (21-23 10.2016) at least once: Club Kwadrat, Bankowa 28/30 Street
17. The laureates, in case of winning the Competition, are obliged to
- a/ pick up their prizes personally during Gala Concert, 21.10.2018, 8:00 pm.
 - b/ take part in the Concert in Jelenia Góra without extra pay, 21.10.2018, 10:30 pm. – 00:00 pm.

III Jury

1. The Jury of the Competition appointed by the Organizer evaluates the Participants.
2. The jury consists of outstanding jazz musicians and music teachers from Poland, Czech Republic and Germany.
3. The Jury works on the basis of the Rules of the Jury.
4. The decision of the Jury of the Competition is final and irreversible.

IV PRIZES

1. The following main prizes are awarded to top finalists:
 - 1st Prize (so called Grand Prix) PLN 6000 + Zloty Krokus Statuette
 - 2nd Prize PLN 4000
 - 3rd Prize PLN2000
 - Special Prize (Honorable Mention) PLN 3200 or non-cash prizes
2. **The Jury is entitled to alter the set, number and amount of prizes, within the financial means stated in the Rules.**
3. Cash prizes are paid only by bank transfer into the Participant`s bank account no later than 15. 11. 2018 (Polish Participants in PLN, Others in EU).
4. The sums shown above are subject to applicable tax reductions required by Polish Law: 18% for Polish musicians, 20% for others Participants.
5. All participants receive commemorative diplomas and 10x CD albums of “The Breath of Young Jazz” Concert released by the Organizer every year (all publishers on www.krokusjazz.festiwal.pl)

V Final provisions

1. The Participants give royalty-free license to the Organizer for: recording, rendering, marketing, processing, playing in public and publishing songs presented during the Competition and at the accompanying concerts.
2. Formal and civil liability bears a person who applies.
3. If the conditions (TERMS AND CONDITION OF PARTICIPATION) are not met, the Organizer reserves the right to
 - a/ reject the application (clauses 1-6 and 12)
 - b/disqualify the Participants or award only Honorably Mention (The Statue and diplomas) without a prize in money (clauses 16-17).
4. The Participants are obliged to inform the Organizer of resignation from the Competition.
5. The Organizer reserves the right to reimbursement of accommodation and subsistence expenses from a person who apply if the condition (clause 4) is not met. The Participants are obliged to provide a valid reason of resignation (e. g. doctor`s certificate) after 18. 10. 2018.
6. Submitting Offers for participation in the Competition is tantamount to accepting the Rules of the Competition and is a contract between the Organizer and the Participants.
